- Candidates can apply for **CMAT 2024 through "Online" mode only. The Application Form in any other mode will not be accepted.**

- Instructions for filling Online Application Form:**
  - ❖ Download Information Bulletin and Replica of Application Form. Read these carefully to ensure your eligibility.
  - ❖ **Follow the steps given below to Apply Online:**
    - Step-1:** Apply for Online Registration using own Email Id and Mobile No.
    - Step-2:** Fill in the Online Application Form and note down the system generated Application Number. Upload scanned images of: (i) a recent photograph (file size 10Kb – 200Kb) either in colour or black & white with 80% face (without mask) visible including ears against white background; (ii) candidate's signature (file size: 4kb - 30kb); (iii) PwD

certificate (file size: 50kb to 300kb), if applicable.

**Step-3:** Pay fee using **SBI and HDFC Bank through Net Banking/Debit Card/Credit Card/UPI** and keep proof of fee paid.

- ❖ Download, save and print a copy of Confirmation Page of the Application Form (which would be downloadable only after successful remittance of fee) for future reference.
  - ❖ All the 3 Steps can be done together or at separate timings. The submission of Application of a candidate could be considered as successful and his/her candidature would be confirmed only on the successful transaction/receipt of the prescribed application fee from him/her.
- 5.** The Confirmation Page of the online Application Form will be generated **only after successful payment by the Candidate.**
- In case the Confirmation Page is not generated after payment of fee, then the candidate should approach the concerned Bank/Payment Gateway (in the helpline no. and email given in Annexure-I of the Information Bulletin) for ensuring the successful payment or for obtaining the refund of duplicate / multiple payments.
  - However, if inspite of above action payment has not been successfully made it means that the transaction has not been completed and the amount not reflected in the NTA account. ## **Common Management Admission Test (CMAT)** **For Academic Session 2024-2025**

### **Introduction**

#### **1. About National Testing Agency (NTA)**

The Ministry of Education (MoE), Government of India (GOI) has established the National Testing Agency (NTA) as an independent, autonomous, and self-sustained premier testing organization under the Societies Registration Act (1860) for conducting efficient, transparent and international standards tests in order to assess the competency of candidates for admissions to premier higher education institutions.

The National Testing Agency (NTA) has been entrusted by the Ministry of Education with the task of conducting the Common Management Admission Test (CMAT) w.e.f 2019.

#### **2. About Common Management Admission Test**

The Common Management Admission Test (CMAT) is a National Level Entrance Examination for admission to management programmes in the country. This Test facilitates AICTE Affiliated/ Participating Institutions to select suitable graduate candidates for admission to the Management Courses in their Institutions.

Till 2018, the Test was conducted by All India Council for Technical Education (AICTE). NTA is conducting this Test since 2019.

The CMAT score is accepted by all AICTE - Approved Institutions / University Departments / Constituent Colleges / Affiliated Colleges.

#### **3. Common Management Admission Test (CMAT)-2024**

3.1 CMAT-2024 will be conducted by NTA as **three-hour** entrance Examination in Computer Based Test (CBT) mode to evaluate the candidates' ability across various segments like Quantitative Technique *and Data Interpretation*, Logical Reasoning, Language Comprehension, General Awareness and Innovation & Entrepreneurship, for admission to the Management Courses in the Academic Session 2024-25. The participating Institutes of CMAT-2024 are the Institutions which will be accepting the CMAT Score.

3.2 NTA does not verify the information provided by the candidates during online registration and hence candidature will be **purely provisional** subject to fulfillment of eligibility criteria as per AICTE norms.

3.3 **NTA has no role in counselling for admission to the Management Programmes.** Candidates must apply separately to the desired CMAT-2024 participating Institutions with the CMAT Score 2024. Thereafter, each Participating Institutions will release their respective cut off CMAT Scores which a candidate should meet to get qualified for admission to that particular Institution. Once qualified, the candidate will have to comply with the selection procedure of that particular Institution, which may comprise of Group Discussion (GD) and Personal Interview (PI). The final selection of the candidate will be based on the candidate's performance in GD & PI.

3.4 Candidates are advised to read the details of the admission process of each Participating Institute of CMAT-2024 on their respective websites.

### 4.2 Medium of Question Paper:

The medium of **Question Paper shall be in English only.**

### 4.3 Marking Scheme:

- i) Each question carries 04 (four) marks.
- ii) For each correct response, candidate will get 04 (four) marks.
- iii) For each incorrect response, 01 (one) mark will be deducted from the total score.
- iv) Un-answered/un-attempted will be given no marks.
- v) To answer a question, the candidate needs to choose one option as correct option.
- vi) However, after the process of Challenges of the Answer Key, in case there are multiple correct options or change in key, only those candidates who have attempted it correctly as per the revised Answer key will be awarded marks.
- vii) In case a Question is dropped due to some technical error, full marks shall be given to all the candidates irrespective of the fact who have attempted it or not.

## 5. Eligibility Criteria for CMAT-2024

5.1 The candidate must hold a Bachelor's Degree in any discipline. Candidates appearing for the final year of Bachelor's Degree, whose result will be declared before commencement of admission for academic year 2024-25, can also apply for CMAT-2024.

5.2 The candidate must be a citizen of India.

**5.3 There is no age restriction for appearing in CMAT- 2024.**

## 6. Reservations

6.1 In the case of Institutes run by the Central Government, the reservation would be applicable as mentioned below:

- (i) **15%** of the seats Scheduled Castes (SC) candidates.
- (ii) **7.5%** seats for Scheduled Tribes (ST) candidates
- (iii) **27%** seats for Other Backward Classes (OBC) Non-Creamy Layer (NCL) candidates as per the Central List\*



- (iv) **10%** of the seats for **General Economically Weaker Sections (General - EWS)** candidates
- (v) Persons with Disability (PwD) with 40% or more disability

6.2 Each category will have **5%** reservations for the candidates with 40% or more disability as defined in Section 2 (r) and (zc) of Persons with Disabilities (RPwD) Act, 2016.

6.3 In the case of the Institutes run/aided/recognized by State Governments, the reservation policy of the respective State Governments shall be applicable.

**Notes:**

1. The benefit of reservation for admission to Central Educational Institutions (CEIs) shall be given only to those classes/castes/tribes which are in the respective Central List published by the Government of India from time to time.
2. *\*Other Backward Classes - Non-Creamy Layer (OBC-NCL) are as per the Central list of Other Backward Classes available on National Commission for Backward Classes (NCBC), Government of India website [www.ncbc.nic.in](http://www.ncbc.nic.in). Thus, the candidates falling in this list may mention OBC in the Category Column. State list OBC Candidates who are not in OBC-NCL (Central List) must choose General.*
3. **Economically Weaker Section (EWS)** - This provision would be regulated as per the OM No. 20013/01/2019-BC-II dated January 17, 2019 issued by the Ministry of Social Justice and Empowerment and the OM No. 12-4/2019-U1 dated 17.01.2019 as well as the Letters No 35-2/2019-T.S.I dated 21.01.2019, 01.02.2019, 04.02.2019 and 15.02.2019 of MHRD Department of Higher Education regarding implementation of reservation for Economically Weaker Section (EWS) for admission in Central Educational Institutions

## 7. Provisions relating to Persons with Disability (PwD):

7.1 As per Section 2(t) of the RPwD Act, “**Persons with Disability (PwD)**” means a person with long term physical, mental, intellectual, or sensory impairment which, in interaction with barriers, hinders his full and effective participation in society equally with others.

According to Section 2(r) of the RPwD Act, 2016, “**persons with benchmark disabilities**” means a person with not less than forty percent (40%) of a specified disability where specified disability has not been defined in measurable terms and includes a person with disability where specified disability has been defined in measurable terms, as certified by the certifying authority.

The “**specified disabilities**”, which are included in the Schedule of the RPwD Act, are as follows:

## 7.2 Facilities for PwD candidates to appear in the exam

As per the guidelines issued by the Department of Empowerment of Persons with Disabilities (Divyangjan) under Ministry of Social Justice & following facilities will be made available to Person with Benchmark Disability:

- a. In case of persons with benchmark disabilities in the category of blindness, locomotor disability (both arms affected-BA) and cerebral palsy, holding a disability certificate in the format prescribed in Annexure- II, the facility of scribe/reader/lab assistant shall be given, if so desired by the person.

In the case of other category of person with benchmark disability the provision of scribe/reader/lab assistant can be allowed on production of certificate to the effect that the person concerned has physical limitation to write and scribe is essential to write examination

on his/her behalf, from the Chief Medical Officer/ Civil Surgeon/ Medical Superintendent of a Govt. Healthcare Institution as per Profoma at Annexure-II.

NTA will arrange for providing scribe to such candidates based on the requirement indicated in their Application Form.

- b. *Compensatory time* of **one hour** for Examination of **three hours** duration would be provided, whether such candidate with benchmark disability uses the facility of Scribe or not.

The NTA does not guarantee any change in the category or sub-category (PwD status) after the submission of the Online Application Form, and in any case, no change will be entertained by NTA after the declaration of CMAT 2024 NTA Scores. Therefore, the candidates are advised to fill in the category / sub-category column very carefully.

**Note: PwD certificate (file size: 50kb to 300kb) may be uploaded while filling in the Application Form.**

### 7.3 Services of a Scribe

As per the office memorandum of the Ministry of Social Justice and Empowerment (Reference: F.No. 34-02/2015-DD-III dated August 29, 2018), the PwD candidates who are visually impaired OR have a disability in the upper limbs OR have lost fingers/hands thereby preventing them from properly operating the Computer Based Test platform may avail the services of a scribe (amanuensis).

The scribe will help the Candidate in reading the questions and/or keying in the answers as per the directions of the Candidate.

A scribe will NEITHER explain the questions NOR suggest any solutions.

PwBD candidates who desire to avail the services of a scribe need to opt for this during the online registration. A copy of the PwBD certificate must be uploaded at the time of online registration. If a candidate desires to bring his/her own Scribe, then he/she should submit a Letter of undertaking for using own Scribe as per the format available at Annexure- II (B).

It is to be noted that the Scribe may be provided by the National Testing Agency if requested in the online application form. However, the candidate is also permitted to bring his/her own scribe, if he/she so chooses.

However, in case a PwBD Candidate is bringing his/her own scribe, the qualification of the scribe should be one step below of the qualification of the candidate taking the examination. Such candidates have to submit the details of the own scribe at the examination centre as per the proforma prescribed at Annexure-II (B) of the said Guidelines.

If it is found at any stage that a candidate has availed the services of a scribe and/or availed the compensatory time, but does not possess the extent of disability that warrants the use of a scribe and/or grant of compensatory time, the candidate will be excluded from the process of evaluation, ranking, counseling, and admission. In case such a candidate has already been admitted to any Institution, the admission of the candidate will be cancelled.

Candidates are advised to go through the Public Notice No. No.NTA/Exam/PwD/Scribe/2022 dated 11.09.2022 on the NTA website [www.nta.ac.in](http://www.nta.ac.in) in this regard.

The NTA does not entertain any change in the category or sub-category (PwBD status) after the completion of correction window of the online Application Form. Further, no change will be entertained by NTA after the declaration of NTA Score for the Exam. Therefore, the candidates are advised to fill in the category/sub-category column very carefully.

Note:

1. The minimum degree of disability should be 40% (Benchmark Disability) in order to be eligible for availing reservation for persons with specified disability.
2. The extent of "specified disability" in a person shall be assessed in accordance with the "Guidelines for the purpose of assessing the extent of specified disability in a person included under the Rights of Persons with Disabilities Act, 2016 (49 of 2016)" notified in the Gazette of India by the Ministry of Social Justice and Empowerment [Department of Empowerment of Persons with Disabilities (Divyangjan)] on 4 January 2018.
3. No change in the category will be entertained later.

Candidates must note that the benefit of reservation will be given to them subject to verification of documents. If it is discovered at any stage that a candidate has used a false/fake/incorrect document, or has furnished false, incorrect, or incomplete information, in order to avail the benefit of reservation, then such a candidate shall be excluded from all admission processes. In case such a candidate has already been given admission, the admission shall stand cancelled.

**8. Guidelines for conducting written examination for persons with specified disabilities covered under the definition of Section 2(s) of the RPwD Act, 2016 but not covered under the definition of section 2(r) of the said Act i.e. persons having less than 40% disability and having difficulty in writing**

- I. These guidelines may be called as Guidelines for conducting written examination for persons with specified disabilities covered under the definition of Section 2(s) of the RPwD Act, 2016 but not covered under the definition of Section 2(r) of the said Act, i.e. persons having less than 40% disability and having difficulty in writing.
  - II. The facility of scribe and/or compensatory time shall be granted solely to those having difficulty in writing subject to production of a certificate to the effect that person concerned has limitation to write and that scribe is essential to write examination on his/her behalf from the competent medical authority of a Government healthcare institution as per proforma at Annexure-III (A).
  - III. The medical authority for the purpose of certification as mentioned in point (II) above should be a multi-member authority comprising the following: -
    - i. Chief Medical officer/Civil Surgeon/Chief District Medical Officer.....Chairperson
    - ii. Orthopaedic/PMR specialist
    - iii. Neurologist, if available\*
    - iv. Clinical Psychologist/Rehabilitation Psychologist/ Psychiatrist/Special Educator
    - v. Occupational therapist, if available\*
    - vi. Any other expert based on the condition of the candidate as may be nominated by the Chairperson. (\*the Chief Medical Officer/Civil Surgeon/Chief District Medical Officer may make full efforts for inclusion of neurologists, occupational therapist from the nearest District or the Medical College/Institute, if the same is not available in the District)"
  - IV. Compensatory time not less than 20 minutes per hour of the examination should be allowed for persons who are eligible for getting scribe. In case the duration of the examination is less than an hour, then the duration of the compensatory time should be allowed on prorata basis. Compensatory time should not be less than 5 minutes and should be in the multiple of 5.
- **Physical Disability certificate (Unique Disability Identification (UDID))** issued by the notified medical authority needs to be uploaded in the Online Application Form of CMAT – 2024.

## 9. Choice of Cities for Exam Centre

- 9.1 The City of Examination Centres where the test shall be conducted are given at Annexure-IV. **It is mandatory for candidates to select four cities of their choice while filling Online Application Form of CMAT 2024.** Effort will be made to allot Centre of Examination to the candidates in order of the City Choice opted by them in their Application Form. However, due to logistic & administrative reasons, a different city of nearby area may be allotted.
- 9.2 The City of Examination once chosen and allotted cannot be changed (after the closing of the correction window) and any request in this regard will not be entertained.
- 9.3 NTA will allocate the Examination centre in the chosen city, which will be mentioned in the Admit Card.

## 10. General Instructions

- 10.1 CMAT 2024 is an Examination for Admission to Management Programme Courses for 2024-25 Academic Session.
- 10.2 Merely appearing in CMAT 2024 does not make a candidate qualified and eligible for admission in Institutions and it does not confer any automatic rights to secure a PG seat.
- 10.3 Online Registration begins on 29 March, 2024 onwards and must be completed by 18 April, 2024 (upto 09.50 PM)
- 10.4 Fee can be deposited by the candidates till 18 April, 2024 (upto 11:50 pm).
- 10.5 However, registered candidates can edit their particulars in certain field during the correction window between 19 April, 2024 to 21 April, 2024 (upto 11:50 pm). No new registrations will be entertained during the correction period.
- 10.6 Applications of candidates producing false or fabricated information will not be considered and candidates may be debarred from appearing in any future examinations conducted by NTA/AICTE.
- 10.7 Before initiating registration process, candidates should go through the Information Bulletin carefully for eligibility criteria, scheme, and pattern of Examination etc. Any queries and other issues will only be entertained if the requested information is not given in the Information Bulletin.
- 10.8 Incomplete application, if not in accordance with instructions, will not be considered and is liable to be rejected. Applicant should carefully fill up all the fields during registration process correctly. Application cannot be modified/edited, after the closing of correction window period.
- 10.9 **The Examination Fee once paid will neither be refunded nor be carried forward under any circumstances.**
- 10.10 NTA/AICTE reserves the right to withdraw permission, if any, granted inadvertently to any candidate who is not eligible to appear in CMAT 2024 even though Admit Card/Registration Number has been issued or is displayed on website.
- 10.11 Candidates must verify criteria of eligibility for admission from the respective institutions

where they want to seek admission.

- 10.12 The existing schedule, pattern, policy and guidelines are for ready reference only but in no way, they are or are ought to be treated as representative or acknowledgment of fact that NTA/AICTE is bound to follow the same in future.
- 10.13 In case of any ambiguity in interpretation of any of the instructions/terms and conditions/ rules/criteria regarding the determination of eligibility/conduct of examinations/ registration of candidates/information contained herein, the interpretation of the NTA/AICTE will be final and binding.
- 10.14 Requests shall not be entertained for change in date or subject of examination.
- 10.15 Absentees from the Examination will forfeit their Examination fee. No further communication will be acknowledged in this regard.
- 10.16 Result for CMAT 2024 will be available on the website <https://exams.nta.ac.in/CMAT/> only.
- 10.17 Candidates should ensure before applying for online registration that their degree is recognized as per provisions of AICTE. If it is found at any time that degree is not recognized, the candidature/result of the candidate shall be cancelled.
- 10.18 **All the correspondence should be addressed by e-mail.** The e-mail query shall be addressed only if it is not anonymous and contains the name, postal address and contact number of the sender. An e-mail containing vague or general queries and other queries as contained in the Information Bulletin shall not be entertained. Queries shall not be entertained from person claiming themselves to be representative, associates or officiates of the applicant candidate.
- 10.19 The following information shall not be revealed by phone or email:
- a. Internal documentation /status of NTA
  - b. Internal decision-making process of NTA/AICTE, Any claim/counter claim thereof
  - c. Dates and venue of internal meetings or name of the staff/officers dealing.
  - d. Any information which in the opinion of NTA/AICTE cannot be revealed.
- 10.20 Terms & Conditions of CMAT 2024 as mentioned in the Information Bulletin shall apply.
- 10.21 CMAT 2024 will be conducted by NTA at exam centers engaged for the purpose. Candidates are advised to familiarize themselves with the route and location of the exam centre. (Refer to Annexure IV for List of Exam cities)
- 10.22 Candidates are advised to look into the website <https://exams.nta.ac.in/CMAT/> regularly for various information, updates and notices pertaining to CMAT 2024 examination.
- 10.23 Kindly note that by registering for the CMAT 2024, candidates are covered by Non-Disclosure Agreement (NDA). As per NDA, candidates cannot disclose any question or contents of question paper in part or otherwise with any person or party or website or such other media/publication. Any act in breach of the NDA shall be liable for penal action as per law. Kindly note that this is a punishable offence and shall lead to cancellation of candidature.



- 10.24 Candidates are deemed to have read, agreed and accepted the contents of Information Bulletin and the terms and conditions in the information bulletin for CMAT 2024 on completing the registration/Online Application Form by the candidates.
- 10.25 Candidates can register for **CMAT 2024 only once**.
- 10.26 Possession/Use of mobile phone or any such electronic devices is strictly prohibited in the premises of CMAT 2024 Test Centers. Candidates shall be liable for penal action for Possession/ Use of Mobile phones/ Electronic devices.
- 10.27 The jurisdiction for court cases/disputes shall be within the exclusive jurisdiction of **competent courts at Delhi/New Delhi only**.

## 11. Registration and Application Process

### Instructions for filling online Application Form

- 11.1 Candidates have to apply for CMAT-2024 “Online” ONLY by accessing the website: <https://exams.nta.ac.in/CMAT/> The Application Form other than online mode would not be accepted in any case. Only one application is to be submitted by a candidate. More than one application i.e. multiple Application Forms submitted by a candidate will be rejected.
- 11.2 It is suggested that the candidate should keep the following ready before starting the filling of the Application Form:
- A computer with proper internet connectivity
  - The particulars of a valid Government ID proof
  - The Date of Birth (as mentioned in Class X Board Certificate)
  - Govt Identity Details like Aadhaar Number (last 4 digits)/Election Card (EPIC No.)/Passport number/Ration Card Number/ Bank Account Number/PAN Number/ Other valid Govt IDs.
  - Educational/Qualification details
  - Scanned clear passport photograph in JPG/JPEG format (size between 10 kb–200 kb) either in colour or black & white with 80% face (without mask) visible including ears against white background.
  - Scanned clear signature in JPG/JPEG format (size between 4 kb–30 kb)
  - PwD certificate (file size: 50kb to 300kb), if applicable.
  - List of City of your choice (Refer Annexure-IV for Cities)
  - Bank account details for payment of fee.
  - A valid e-mail Id as important communications will be made on this e-mail ID.
  - A valid mobile number as important information via SMS will be sent to this number.
  - A valid debit/credit card or Net banking account for ONLINE payment.
- 11.3 Information Bulletin should be downloaded and read carefully by the candidate to be sure about his/her eligibility and acquaint themselves with requirements for submission of Online Application Form.
- 11.4 In order to avoid correction in the particulars in later stage, the candidate should *exercise utmost caution while filling up correct details*.
- 11.5 Follow following Steps may be followed to Apply Online:

**Step-1:** Apply for Online Registration using own Email ID and Mobile No.

**Step-2:** Fill in the Online Application Form and note down the system generated Application Number. Upload scanned images of: (i) the recent photograph (file size 10Kb – 200Kb) either in colour or black & white with 80% face (without mask) visible including ears against white background; (ii) candidate's signature (file size: 4kb - 30kb) (iii) PwD certificate (file size: 50kb to 300kb), if applicable.

**Step-3:** Pay fee using **SBI and HDFC Bank Gateway through Net Banking/Debit Card/Credit Card/UPI** and keep proof of fee paid.

All the 3 Steps can be done together or at separate timings. The submission of Application of a candidate could be considered as successful and his/her candidature would be confirmed only on the successful transaction/receipt of the prescribed application fee from him/her.

**Note:**

- (i) The final submission of Online Application Form will remain incomplete if Step - 2 and Step-3 are not completed, such Application Forms will stand rejected and no correspondence on this account will be entertained.
- (ii) No request for refund of fee once remitted by the candidate will be entertained.
- (iii) The entire application process of CMAT-2024 is online, including uploading of scanned images, Payment of Fees and Printing of Confirmation page. Therefore, candidates are not required to send/submit any document(s) including Confirmation page to NTA through Post/Fax/By Hand/E-mail.
- (iv) Candidates are advised to keep visiting the NTA's website regularly for latest updates and to check their e-mails.
- (v) The NTA can make use of the data generated for the purpose of research and analysis.
- (vi) All the candidates who have submitted the online application and paid the Examination fee till last date will be allowed to appear in CMAT-2024 and their Admit Cards will be uploaded on the website as per schedule.
- (vii) NTA does not verify the information filled by the candidates in the Application Form nor verifies any certificate of category/educational qualification for deciding the eligibility of candidates.
- (viii) The certificates of educational qualification and category (if applied under reserved category) will be verified by the concerned institution. The candidates are, therefore, advised to ensure their eligibility and the category (if applying under reserved category).
- (ix) The NTA will, in no way, be responsible for any wrong/incorrect information furnished by the candidate(s) in his/her Online Application Form. The letter/emails/WhatsApp Message/Public Grievance in this regard will not be entertained by the NTA.

- (iii) **Mobile Number and e-mail Address:**  
Candidates must provide own Mobile Number and e-mail address.

**Note: Only one e-mail address and one Mobile Number are valid for one application**

## 11.8 Important Points to Note:

## 12. Admit Card for CMAT-2024

1. The Admit Card is issued provisionally to the candidates, subject to their satisfying the eligibility conditions.
2. The candidate has to download the Admit Card from the NTA website and appear for the Examination at the given Centre on Date, timing and discipline as indicated in their Admit Card.
3. No candidate will be allowed to appear at the Examination centre, on Date and timing other than that allotted to them in their Admit Card.
4. In case candidates are unable to download Admit Cards from the website, they may approach the Help Line between 10:00 am to 5:00 pm.
5. **The candidates are advised to read the instructions on the Admit Card carefully and follow them during the conduct of the examination.**
6. In case of any discrepancy in the particulars of the candidate or his/her photograph and signatures shown in the Admit Card and Confirmation Page, the candidate may immediately **approach the Help Line between 10:00 am to 5:00 pm. In such cases, candidates would appear in the Examination with the already downloaded Admit Card. However, NTA will take necessary action to make correction in the record later.**

### **Note:**

- a. Candidate may please note that Admit Cards will not be sent by post.
- b. In no case, the duplicate Admit Card for CMAT-2024 would be issued at the Examination Centres.
- c. Candidate must not mutilate the Admit Card or change any entry made therein.
- d. Candidates are advised to preserve their Admit Cards in good condition for future reference.
- e. No Admit Card shall be issued to the candidates whose Applications are found to be incomplete for any reasons (including indistinct/ doubtful photographs/unsigned Applications) or who do not fulfill the eligibility criteria for the examination.

Any one of the authorized photo IDs (must be original, valid and non-expired) – PAN card/ Driving License/ Voter ID/ Passport/ Aadhaar Card (With photograph)/ Aadhaar Enrolment No/ Ration Card). The name on the photo identification must match with the name as shown on the Admit Card.

- iv. **PwD certificate** issued by the Competent Authority, if claiming the relaxation under PwD category.
- v. **PwD certificate** issued by the Competent Authority, if claiming the relaxation under PwD category below 40% category.

The detailed procedure for CBT is provided at Annexure-V. Please read them carefully.

### 14. Conduct of the Examination

#### 14.1 Important Instructions for Candidates

**(Candidates are advised to go through instruction printed on Admit Card carefully before going for the Examination)**

- a. Candidates MUST bring the following documents on the day of Examination at the test centre. Candidates who will not bring these will not be allowed to appear in the examination.
  - i. Print copy of Admit Card downloaded from NTA website
  - ii. One passport size photograph (same as uploaded on the Online Application Form) for pasting on the specific space in the attendance sheet at the Centre during the Examination
  - iii. Any one of the authorized Govt photo IDs (original, valid and non-expired), viz. PAN card/ Driving License/ Voter ID/ Passport/ Aadhaar Card (With photograph)/ Aadhaar Enrolment No/ Ration Card
  - iv. PwD certificate issued by the Competent Authority, if claiming the relaxation under PwD category.

If the name has been changed due to events such as marriage, candidate must show the relevant document at the time of exam. Marriage Certificate / Divorce / Decree / Legal Name Change Document.

- b. The candidates shall report at the Examination Centre **two hours before the commencement of the Examination** so as to complete the registration formalities well before the time of exam.
- c. Registration desk will close 90 minutes prior to the examination.
- d. The candidates are advised to read the instructions on the Admit Card carefully and follow them strictly.
- e. Candidates should take their seat immediately after opening of the Examination hall on their allotted seat. If not they are likely to miss some of the general instructions to be announced in the Examination Rooms/Halls. The NTA shall not be responsible for any delay.

- f. Any candidate found to have changed room/hall or the seat on his/her own other than allotted would be considered as a case of Unfairmeans and the candidature shall be cancelled, and no plea would be accepted.
- g. The candidate must show, on demand, the Admit Card for entry in the Examination room/hall. A candidate who does not possess the valid Admit Card shall not be allowed to enter the Examination centre.
- h. The candidate should ensure that the question paper available on the computer is as per the opted Subject Code/ Discipline indicated in the Admit Card. In case, the subject of question paper is other than the opted paper, the same may be brought to the notice of the Invigilator concerned.

- 1. The list of cities where Examination Centers are located is given at **Annexure –IV**. Candidates shall appear at the centre as shown on their Admit Cards at their own cost. No TA, DA or any accommodation facility will be admissible for appearing in CMAT 2024.
- 2. Candidate has the option of choosing four cities for the Examination during the Online Application.
- 3. Candidates are advised to familiarize themselves with the location of test centre and plan travel time accordingly. Candidates have to reach the test centers on or before the reporting time. Candidates may note that late entry to the Examination premises is not permitted under any circumstances. NTA/AICTE shall not be responsible for any delayed arrival of the candidate in reaching the centre due to any reason.

4. Biometric information of all the candidates shall be captured.
5. Identity checks will be made upon arrival at the test centre to ensure that there are no unauthorized candidates appearing for the test. Candidates are required to cooperate with the security personnel for security checks.
6. Please note that only registered candidates will be allowed at the Examination Centre.
7. Friends or relatives accompanying the candidates shall not be allowed entry in the test centre under any circumstances and will not be allowed to contact the candidate while the Examination process is going on.

- h) Using or attempting to use any other undesirable method or means in connection with the examination;
- i) Manipulation and fabrication of online documents viz. Admit Card, Rank Letter, Self-Declaration, etc.;

## 17. Display of Recorded Responses

The NTA will display the recorded responses and Question Paper attempted by the candidates on the NTA website <https://exams.nta.ac.in/CMAT/> prior to declaration of result. The recorded responses are likely to be displayed for two to three days.

## 18. Display of Provisional Answer Key for Challenges

1. The NTA will display Provisional Answer Key of the questions on the NTA website: <https://exams.nta.ac.in/CMAT/> with a Public Notice issued to this effect on the said website, to provide an opportunity to the candidates to challenge the Provisional Answer Keys with a non-

refundable online payment of ₹ 200/- per question challenged as processing charges. The provisional Answer Keys are likely to be displayed for two to three days.

2. Only paid challenges made during stipulated time through key challenge link will be considered.
3. The NTA's decision on the challenges shall be final and no further communication will be entertained. NTA will not inform the Candidates individually about their challenges.
4. The subject experts will examine all the challenges received and then a final answer key will be displayed, and Results will be declared based on it.

## 19. Declaration of Results

The result will be compiled based on Final Answer Keys. No grievance with regard to Answer Key(s) after Declaration of Result of CMAT-2024 will be entertained. The raw (actual) marks obtained by a candidate will be considered further for computation of the Result of CMAT-2024. No Score Card will be dispatched to the candidates and the candidates are advised to download their Score Cards from the website: <https://exams.nta.ac.in/CMAT/> only.

The National Testing Agency (NTA) is an Examination conducting body and will provide CMAT Score 2024. The NTA does not collect the information regarding total number of seats available in the Institutions and reservation criteria followed by the Institutions.

### **Rules for tie-breaking: -**

- A National Merit Ranking (All India Rank) will be arrived based on the Score secured against Total Score.
- Cumulative grade point average (CGPA) of last graduation examination.
- Overall percentage marks of class 12.
- Older in age
- Candidates having same score would be given the same Merit, and the Merit number would be increased by the same number i.e. if there are two candidates at Merit 2, Merit 3 would not be awarded to the next candidate, but Merit 4 would be given.

## 20. Normalization procedure (Annexure – VI):

- a) For multi-shift papers, raw marks obtained by the candidates in different shifts/sessions will be converted to NTA Score (percentile).
- b) The detailed procedure on NTA Score being adopted is available on NTA website under Normalization procedure based on Percentile Score.
- c) In case a subject test is conducted in multi-shifts, NTA Score will be calculated corresponding to the raw marks obtained by a candidate. The calculated NTA Score for the Raw Marks for all the shifts/sessions will be merged for further processing for deciding the allocation.
- d) In the events of the percentiles for the multi-shifts being dissimilar / unequal, the lowest will be the eligibility cut-off for that category for all candidates (i.e. all shifts).

For Example: In the examination held in two shifts, if the 40% marks correspond to a Percentile score of 78 in Shift 1 and 79 in Shift 2, then all those equal to or above 78 percentiles (Percentile score of 100 to 78) in both shifts will become eligible in General Category. Similar method will be adopted for the other categories to determine eligibility cut-offs. In case the examination is held in a greater number of shifts the same principle shall apply.

## 21. Re-Evaluation/Re-Checking of result

There shall be no re-evaluation/re-checking of result. No correspondence in this regard shall be entertained.

## 22. Correspondence with NTA

All the correspondence should be addressed by e-mail to NTA on <https://exams.nta.ac.in/CMAT/>. The email query shall be addressed only if it is not anonymous and contains the name, Registration/Application No, postal address and contact number of the sender. An email containing vague or general queries and other queries as contained in the Information Bulletin shall not be entertained. Queries shall not be entertained from person claiming to be representatives, associates or officiates of the applicant candidate. The following information shall not be revealed by phone or email:

- a. Internal documentation/status.
- b. Internal decision-making process of NTA. Any claim/counter claim thereof.
- c. Dates & venue of internal meetings or name of the staff/officers dealing with it.
- d. Any information which in the opinion of NTA cannot be revealed.

## 23. Query Redressal System

National Testing Agency (NTA) has established a Query Redressal System (QRS), an online web-enabled system developed by NTA. QRS is the platform based on web technology which primarily aims to enable submission of queries/grievances by the Registered Candidate(s) of CMAT 2024 Examination with (24x7) facility for speedy redressal of the queries/grievances. A Unique Registration Number will be generated for tracking the status of the queries/grievances.

The Registered Candidate(s) are advised to use the online facility for speedy response before mailing their queries on the official email id of CMAT.

## 24. Weeding Out Rules

The record of Common Management Admission Test (CMAT) - 2024 would be preserved upto 90 days from the date of declaration of result.

## 25. Legal Jurisdiction

All disputes pertaining to the conduct of CMAT- 2024 Examination including Results shall fall within the **jurisdiction of Delhi / New Delhi** only. Further, any legal question arising out of the Examination shall be entertained only when raised within 30 days from the declaration of result.

**Computer Based Test (CBT)**

- (a) A computer terminal (node) indicating Roll Number will be allotted to each candidate. Candidates should find and sit on their allotted computers only. Any candidate found to have changed room/hall or the computer on their own rather than the one allotted would be liable to cancellation of candidature and no plea in this regard would be entertained.
- (b) The computer terminal allotted to the candidate will display Welcome login screen, Candidate's photograph and subject opted by the candidate. For login, the candidate will have to enter login-ID and password.
- (c) After logging in, the candidate shall be able to see the detailed instructions for the examination. Candidates are advised to go through the instructions carefully regarding the type of questions and Marking Scheme. At the designated time of start of the examination, the candidates will be able to proceed and see the questions on the computer screen.

The keyboard attached to the computer, if any, will be disabled during the entire duration of the examination. Depending on the type of question, the answers to questions can either be entered by clicking on the virtual on-screen keyboard (numeric or otherwise) using the computer mouse or by clicking the chosen option(s) using the computer mouse. Candidates will have the option to change/modify answers already entered anytime during the entire duration of the examination.

In case the computer/mouse allotted to any candidate malfunctions anytime during the test, the candidate will be immediately allotted another computer system and the time lost due to this will be adjusted in the server so as to give the candidate the full allotted time.

- (d) The on-screen computer clock counter of every candidate will be set at the server. The countdown timer in the top right side of computer screen will display the time remaining (in minutes) available for the candidate to complete the examination. When the timer reaches zero, the examination will end by itself. Candidate will not be required to end or submit the examination.
- (e) The Question Palette displayed on the right side of screen will show the status of each question using one of the following text/color codes/symbols.

-  - Questions not attempted but viewed
-  - Question answered and Mark for Review
-  - Questions not attempted but viewed and Mark for Reviewed.

The question(s) “Answered and Marked for Review” status for a question indicates that candidate would like to have a relook at that question again. A candidate has the option of answering a question and simultaneously placing it under “Marked for Review”, these answers will be considered for evaluation. However, if a candidate has simply put “Marked for Review” for a question without answering it, the corresponding question ‘Marked for Review’ without an answer will not be considered for evaluation. It may be noted that a candidate can return to any “Marked for Review” question any time during the examination by clicking on the corresponding question number icon displayed on the Question Palette of the corresponding section.

- (f) Candidate can click on an arrow/symbol which appears to the left of question palette to collapse the question palette thereby maximizing the question viewing window. To view the question palette again, candidate can click on arrow/symbol which appears on the right side of question window.
- (g) Candidate can click to navigate to the bottom and to navigate to the top of the question area, without scrolling. Using the computer mouse the candidate can scroll up and down the question viewing area for viewing the entire question.
- (h) Blank Sheets for doing rough work/calculations shall be provided to the candidates. The Blanks Sheets would have a Header page for the candidates to write down his/her Name and Roll Number. All calculations/writing work are to be done only in the Blank Sheets provided at the Centre in the Examination Room/Hall and on completion of the test, candidates must hand over the rough sheets to the invigilator on duty in the Room/Hall.

**(i) Navigating to a Question**

To navigate between questions within a Paper, candidate needs to do the following:

- i. Click on the question number in the Question Palette at the right of the screen to go to that numbered question directly. Note that using this option does NOT save the answer to the currently displayed question.
- ii. Click on “Next” to save the answer of any question. Clicking on “Next” will save the answer for the current question and the next question will be displayed on the candidate’s computer screen.
- iii. Click on “Flag” to mark a question for review (without answering it) and proceed to the next question.

**(j) Answering a Question**

To navigate between questions within a Paper, candidate needs to do the following:

Procedure for answering a multiple-choice type question:

- To select the option(s), click on the corresponding button(s) of the option(s)
- To deselect the chosen answer, click on the button of the chosen option again or click on the “Clear Response” button.
- To save the answer, the candidate MUST click on the “Next” button.
- To mark the question for review (without answering it), click on the “Flag” button.

**(k) Navigating through sections:**

- i. Sections in the question paper are displayed on the top bar of the screen. Questions in a section can be viewed by clicking on the section name. The section in which candidate is currently viewing will be highlighted.
- ii. After clicking the “Next” button on the last question for a section, candidate will automatically be taken to the first question of the next section.
- iii. Candidate can shuffle between sections and questions within sections any time during the examination as per the convenience only during the time stipulated.
- iv. Candidate can view the corresponding section summary as part of the legend that appears in every section above the question palette.

**(l) Procedure for answering questions that require inputs from on-screen virtual key board (numeric or otherwise):**

- i. Candidate will have to use the on-screen virtual keyboard (that would be displayed just below the question statement of these type of questions) and the attached computer mouse to enter his/her answer in the space provided for answer.
- ii. The answer can be changed, if required, anytime during the test. To save the answer, the candidate MUST click on the “Next” button.
- iii. To mark the question for review (without answering it), click on the “Flag” button.

**Candidate will have the option to change previously saved answer of any question, anytime during the entire duration of the test. To change the answer to a question that has already been answered, first select the corresponding question from the Question Palette, then click on “Clear Response” to clear the previously entered answer and subsequently follow the procedure for answering that type of question.**

**(m) Rough Work:**

All calculations/writing work is to be done only in the rough sheet provided at the Centre in the examination Room/Hall and on completion of the test candidates must hand over the rough sheets to the invigilator on duty in the Room/Hall.

## National Testing Agency (NTA)

### Procedure to be adopted for compilation of NTA scores for multi session Papers (Normalization procedure based on PERCENTILE SCORE)

NTA may conduct examinations on multiple dates, generally in two sessions per day. The candidates will be given different sets of questions per session and it is quite possible that in spite of all efforts of maintaining equivalence among various question papers, the difficulty level of these question papers administered in different sessions may not be exactly the same. Some of the candidates may end up attempting a relatively tougher set of questions when compared to other sets. The candidates who attempt the comparatively tougher Examination are likely to get lower marks as compared to those who attempt the easier one. In order to overcome such a situation, “**Normalization procedure based on Percentile Score**” will be used for ensuring that candidates are neither benefitted nor disadvantaged due to the difficulty level of the examination. With the objective of ensuring that a candidate’s true merit is identified, and that a level playing field is created in the above context, the Normalization Procedure, set out below shall be adopted, for compiling the NTA scores for multi session papers.

**The process of Normalization is an established practice for comparing candidate scores across multi session papers and is similar to those being adopted in other large educational selection tests conducted in India. For normalization across sections, NTA shall use the percentile equivalence.**

**Percentile Scores:** Percentile scores are scores based on the relative performance of all those who appear for the examination. Basically the marks obtained are transformed into a scale ranging from 100 to 0 for each session of examinees.

**The Percentile Score indicates the percentage of candidates that have scored EQUAL TO OR BELOW (same or lower raw scores) that particular Percentile in that examination. Therefore the topper (highest score) of each session will get the same Percentile of 100 which is desirable. The marks obtained in between the highest and lowest scores are also converted to appropriate Percentiles.**

**The Percentile score will be the Normalized Score for the Examination** (instead of the raw marks of the candidate) and shall be used for preparation of the merit lists.

**The Percentile Scores will be calculated up to 7 decimal places to avoid bunching effect and reduce ties.**

**The Percentile score of a Candidate is calculated as follows:**

**100 X Number of candidates appeared in the ‘Session’ with raw score EQUAL TO OR LESS than the candidate.**

**Total number of the candidates appeared in the ‘Session’**

**Note:** The Percentile of the Total shall **NOT** be an aggregate or average of the Percentile of individual subject. Percentile score is not the same as percentage of marks obtained.

**Example:** Suppose a test was held in 4 sessions of examinees as per details given below: -

**(Allocation of Days and shifts were done randomly)**

**(a) Distribution of candidates were as follows:**

**Session-1:** Day-1 Shift-1, **Session-2:** Day-1 Shift-2, **Session-3:** Day-2 Shift-1 and **Session-4:** Day-2 Shift-2

In this method of scoring the HIGHEST RAW SCORE in each paper (irrespective of the raw scores) will be the 100 Percentile indicating that 100% of candidates have scores equal to or lesser than the highest scorer/ topper for that session.

**Highest Raw Score and Percentile Score:** All the highest raw scores will have normalized Percentile Score of 100 for their respective session.

#### STEP-BY-STEP PROCEDURE FOR NORMALIZATION AND PREPARATION OF RESULT:

##### Step-1: Distribution of Examinees in two shifts:

Candidates have to be distributed into two sessions randomly so that each session has approximately equal number of candidates. These two sessions would be as follows:

**Session-1:** Day-1 Shift-1, **Session-2:** Day-1 Shift-2

In the event of more number of days or less number of shifts, the candidates will be divided accordingly.

This will ensure that there is no bias in the distribution of candidates who shall take the examination. Further, with a large population of examinees spread over the entire country the possibility of such bias becomes remote.

##### Step-2: Preparation of Results for each Session:

The Examination results for **each session** would be prepared in the form of

- Raw Scores
- Percentiles Scores of Total raw scores.

The Percentiles would be calculated for each candidate in the Session as follows:

Let TP1 be the Percentile Scores of Total Raw Score of that candidate.

$$\text{Total Percentile (TP1)} : 100 \times \frac{\text{No. of candidates appeared from the session with raw score EQUAL TO OR LESS than T1 score}}{\text{Total No. of candidates appeared in the session}}$$

##### Step-3: Compilation of NTA score and Preparation of Result:

The Percentile scores for the Total Raw Score for all the sessions (**Session-1:** Day-1 Shift-1, **Session-2:** Day-1 Shift-2) as calculated in Step-2 above would be merged and shall be called the NTA scores which will then be used for compilation of result and further processing for deciding the allocation.




In the events of the percentiles for the multi-shifts being dissimilar / unequal, the lowest will be the eligibility cut-off for that category for all candidates (i.e. all shifts).  
For Example: In the Examination held in two shifts, if the 40% marks correspond to a Percentile score of 78 in Shift 1 and 79 in Shift 2, then all those equal to or above 78 percentiles (Percentile score of 100 to 78) in both shifts will become eligible in General Category. Similar method will be adopted for the other categories to determine eligibility cut-offs. In case the Examination is held in more number of shifts the same principle shall apply.
